REGULATION

The event will be organized on the basis of the current anticovid regulations at the time of the race and according to the federal protocols of the Italian Cycling Federation

Art. 1 General characteristics

The Bora Multisport Sports Association - Granfondo d'Europa, is organizing the 20th edition of the CRONOCARSICA - GRANFONDO d'EUROPA - FRIULI VENEZIA GIULIA REGIONAL TIME TRIAL CHAMPIONSHIP on 12 September 2021.

Art. 2 Participants

The event is open to all cyclists and cyclists WITH HEALTH CERTIFICATE FOR CYCLING over the age of 18 in good standing with the FCI membership for the current year and to the members of the organizations that have signed the agreement with the FCI for the year 2021 and to the card-holders of the Bodies presenting the Bike Card together with the card of their own Organization.

The ASD Bora Multisportrieste for Italian citizens WITHOUT MEMBERSHIP in possession of a health certificate FOR CYCLING offers the opportunity to participate in the Granfondo d'Europa with a daily membership at a cost of 10 euros + registration to the race to be signed with adhesion strictly WITHIN 1 SEPTEMBER.

The event is reserved for 200 participants.

Art. 3 Route and Departures

The TWENTIETH edition of the Granfondo d'Europa will take place with the CRONOCARSICA, individual time trial on the following route:

Barcola - Prosecco (Trieste) **km 7**

Suredia Tresecce (Tresec) IIII 2

Departures will be made every 30 "starting at 10.30 at Via Boveto in Barcola. The starting order will be published on Saturday 11 September at 12.00.

Art. 4 Registration

Registration opening - 1st March 2021 Registration deadline - WEDNESDAY 8 SEPTEMBER AT 20.00

They must be accompanied by proof of payment of the registration fee and can be done in two ways:

Art. 6 Withdrawal of Race Packs and timing chip

The collection of race packages and participation accreditations will be possible at the logistic site of the event in Prosecco on the days of:

SATURDAY 11 SEPTEMBER - from 16.00 to 19.00 SUNDAY 12 SEPTEMBER - from 8.00 to 9.30

The timing will be carried out by Winningtime with technology based on the use of "chips". Each participant will be equipped with a daily chip that will be delivered to the race packet collection on a deposit of \in 20 and must be returned at the end of the race, in case of non-return the deposit will be withheld. N.B.: Failure or incorrect use of the chip will result in non-inclusion in the ranking and non-attribution of the time spent.

Art. 7 Safety

The event is of an amateur-sporting nature and the relative rules provided for by the FCI regulations must be respected.

THE USE OF THE RIGID HELMET IS MANDATORY.

Art. 8 Preliminary operations

During the preliminary operations:

- Participants must be in possession of the documents referred to in point a) of Article 9 and show an identity document;
- the president or manager of the club must show the list of participants and make available, if requested by the judges, the official badges as per point b) art.9;
- Participants of Italian nationality must give consent for the use of personal data as required by law 31/12/1996 n. 675 for the purposes connected with the running of the event;
- participants will be given a race envelope containing the number to be applied visibly on the handlebars, the race number, detailed information on the route and for the conduct of the event, the meal voucher.

The gadget will be delivered upon arrival.

Art. 9 Controls, rankings and awards

a) Controls:

- all participants must be members of a cycling club regularly affiliated with the national cycling federation (of the country of origin) and / or other sports promotion body recognized by the National Olympic Committee, and must have the relevant official card issued for the year in course by the Federation (or Promotional Bodies for Italian participants);
- the president, or his representative, of the cycling club must have these cards if requested by the race judges.

They will be awarded:

- the top 5 classified companies
- the first absolute male and female
- the three best times on the sum of the total times relating to the three Grand Prix of each category:

male: A - up to 24 years; B - 25/29 years; C - 30/34 years; D - 35/39; E - 40/44 years; F - 45/49 years; G - 50/54 years H - 55/59 years - K 60/64 years - L 65 and over 65; female: W1 - 19/29 years; W2 - 30/39 years; W3 - 40/49 years; W4 - 50 over 50

The awards will take place from 1 PM

Art. 10 Complaints

They must be sent to the jury in compliance with the provisions of the S.A.N. of the F.C.I.

Art. 11 FCI Regulations

Although not covered herein, the technical regulation and the 2018 implementation rules of the S.A.N. - F.C.I.

Art. 12 Doping control

At the end of each stage, doping control is possible by the competent bodies; therefore, before leaving the finish area, the competitors must make sure that they have not been selected for the aforementioned control.

Art. 13 Liability

The organizing association declines any responsibility for what may happen to participants, third parties or things, before, during and after the event.

By registering, participants declare that they:

- 1) to be 18 years old on the date of the event;
- 2) to be in possession of a valid medical certificate for the performance of competitive activities;
- 3) to recognize that participating in this event is potentially dangerous;
- 4) to assume full and complete responsibility for any injury and / or accident that may occur along the way to and from the event, during the event, or while I am in the places of the event itself;

- 5) to assume all risks associated with participation in this event;
- 6) to exempt and release ASD BORAMULTISPORT TRIESTE, the organizers, managers, promoters, as well as all other persons associated with this event, from any responsibility for any physical injury and / or material damage that I may incur during the 'event and to waive any claim and / or legal action that I could bring against them as a result of participation in such event or in any way connected with it;
